PLEASE READ CAREFULLY and INITIAL items below:

I understand that each guest attending the event must have a signed waiver on file to participate in any activity at Denali Gymnastics or Denali Fitness. This includes waivers for PARENTS, COACHES, EDUCATORS, or ADMINISTRATORS that will be on the gymnastics floor or fitness floor. *Please plan ahead if parents will not be present at the event.*

I agree that all fees associated with this event agreement will be paid in full prior to the scheduled event.

I understand and will ensure that the group chaperone/coach/leader remains with the group at all times.

Parents attending birthday parties should remain in a viewing area until the group has been escorted to the party room (parents of preschool children may be asked to accompany their child in the gym area).

I understand that NO adults are allowed on ANY of the gymnastics equipment, including, but not limited to parallel bars, high bars, uneven bars, rings, vault, trampolines and tumble track, balance beams, gymnastics mats, rope, etc.

I understand that, for the safety of my group, the workout area at Denali Fitness is completely restricted. Participants are allowed in the blue carpet-bonded floor areas only.

I will advise members of my group to wear appropriate gym attire consisting of close-fitting clothing (preferably knits) that do not include snaps, buttons, and/or zippers, and avoiding blue jeans and skirts. Shoes should NOT be worn on the gymnastics floor. Outside shoes will NOT be worn on the gymnastics or rock-climbing floor.

I will help Denali Gymnastics and/or Denali Fitness staff stay on schedule by arriving 15 minutes early for the event and assist them by leaving at the designated time.

WAIVER of LIABILITY:

All precautions will be taken to prevent accidents. Simple First Aid will be administered for minor injuries and parents or doctors will be called when necessary. I hereby consent to have my child participate in programs offered by Denali Gymnastics and Fitness Inc. (DG&F). It is hereby agreed that I, my child/children, adopted or otherwise, my heirs and executors, waive and release all rights and claims for damages that they may have at any time against the center, its representatives, whether paid or volunteer, for injury or damages in connection with the gymnastics program or other activities related to DG&F. The risks involved in respect to such a program are fully understood.
